

Strong growth of full year 2006 Revenue Results



Net income rose to \in 892689, up 43% vs \in 624989 in fiscal year 2005.

The company has no financial debt.



The growth of net sales comes with a proportional growth of the Ebit figure: + 46% at 1286675 vs \in 881079 in 2005.

This demonstrates Hitechpros' ability to control costs within a context of fast development.

Net sales 2006 increased to \notin 6444023 from \notin 4468732 last year, a 44% rise over 2005. This growth rate is very stable since it is the same as the average growth rate since 2002.

This confirms the strong and growing recognition of Hitechpros by the IT sector.
